Mohawk Valley Library System Director's Report November - December 2020

Administration & Governance

We finished 2020 in good financial condition, with a fund balance over \$1 million. While the financial statements show an \$83,000 deficit, they don't incorporate the \$95,000 PPP loan/grant. That funding won't show in the financial statements as income until it is formally "forgiven"; which should happen sometime in the first half of 2021. Also, we may still receive some or all of the state aid that was withheld in 2020. So things are financially OK, and, if more aid is released and the 2021 state budget isn't too painful, they could get a lot better

Thank you for participating in Kathy's retirement acknowledgment and gift. She was very pleased with the result. Sharon O'Brien did a great job with the lottery tickets concept and with the gift.

Heather Dickerson is set to begin work as the MVLS Public Services Consultant on Thursday, January 14. We are very excited to have her begin work on youth services and outreach.

We received well over 100 applications and interviewed four candidates for the Administrative Associate position; and selected Daniele Callihan to be the new MVLS Administrative Associate. Unfortunately, after starting the job and working for a few days, she decided that it wasn't what she expected, and she resigned. We were all shocked: she appeared to be working in well. We are reopening the search. We know there are other candidates still interested, so we should have a new and improved Administrative Associate on staff soon.

We have received the annual audit review proposal from T.M. Byxbee. The 2021 cost will remain the same, at \$3,750 for MVLS and \$2,850 for JA. Since the audit firm works for the board, this requires action at the board meeting.

Cheryl Cufari has been serving as the MVLS Treasurer since 2014. She is now interested in resigning from that office. This presents us with the option of changeing the way MVLS uses the services of a Treasurer. For all public organizations and for most larger private organizations, the Treasurer is a paid employee. Since many of our libraries are required to have a paid Treasurer, I think we should consider doing the same at MVLS. I have developed a draft job description which we can review at the January meeting.

According to the MVLS Bylaws, a nominating committee should be appointed in January. The nominating committee is charged with proposing candidates for trustee positions that become vacant at the next Annual Meeting and developing a slate of officers to be elected at the reorganizational meeting that follows the annual meeting. We have three trustee terms that expire in 2021: Mary Salluzzo, Felicia Spivey and Becky Sokol (apparently it is the year for those whose last name begins with "S"). All are eligible for reelection. Also, with the resignation of Christina Knee, MVLS also has a vacancy in the Vice President position.

Automation and Resource Sharing

The JA Council will hold the first meeting of 2021 on January 13. That meeting typically includes action on the member fees for the following year, in this case for 2022. The JA Finance Committee held an open meeting on December 9 to get member input. The consensus at that meeting was to hold fee income unchanged in 2022, meaning the amount raised from fees will remain at \$726,055; the same figure used in 2020. Also, since fees are ordinarily computed based on data from 2 years previous (2021 fees are computed based on 2019 data), and the library use data for 2020 are so skewed by COVID, the proposal is to continue to use 2019 data to compute 2022 fees. This will have the effect of library fees remaining exactly the same throughout 2021 -2022. Action on JA 2022 fees will be an agenda item at the January board meeting.

Karen Bradley and I have met to discuss the 2021 Central Library Plans. Because this is such an uncertain year – we still don't know what the final values for 2020 Central Library Aid will be, never mind 2021 – we are recommending holding the two central library aid plans steady, to be modified if the aid situation changes. Copies of the 2021 Central Book Aid and Central Library Development Aid plans will be included with the meeting materials on the website. We, along with other library systems around the country, have run into a problem with the E-magazine service that was most recently provided through Overdrive. The company, without any notice, radically changed their service model, effectively pricing MVLS out of the service. We are working with members to find an alternative solution.

Outreach & Adult Services

Heather Dickerson will be starting in January, and part of her role is to perform outreach duties. Initial outreach tasks will be to reinvigorate our work with the county jails and state correctional facility, a restart of the Outreach Advisory Council, and new emphasis on the state adult literacy grant.

A few virtual adult literacy and NYSCA book discussion programs are being held. We are doing what we can to support the continuation of these program series.

There may be a change coming to how the state funds outreach. The Division of Library Development is proposing incorporating all of the small pots of money (adult literacy, institutions, corrections, etc.) into the overall Outreach aid, and letting systems have less record-keeping and more flexibility in meeting local needs. This could begin with the 2021 state budget year.

Youth Services

The 2020 Summer Reading Planning Workshop will be held virtually on Tuesday, February 23. Heather will be working with Mary Fellows to plan and provide this combined MVLS/UHLS program.

Heather will also be working on the Family Literacy state grant, and on the publisher's preview books initiative.

Member Services

Don LaPlant is the new Director at the Schoharie Free Library, replacing Cathy Caiazzo, who retired at the end of the year. MVLS staff has been working with Don on orientation. The Canajoharie Library is in the middle of the search for their new director. Preliminary info is that the search is going well and they are pleased with the candidates. Schoharie and Cobleskill both have active searches for critical support staff.

We are currently assisting Canajoharie, Schenectady and Schoharie with charter and governance issues. Schoharie is amending their charter to expand the service area to the Schoharie School District. Canajoharie is pursuing a charter amendment to update their name and purpose to include the current museum operations. Schenectady is working to regularize their charter and bylaws concerning trustee numbers and terms.

I met with the Amsterdam board in mid-December to provide information on construction, planning and a capital campaign. They have hired a consultant to assist with the implementation of their major building project.

All libraries have received Chromebooks & hotspots through the census project. I am very pleased to see libraries embracing using these resources to serve their communities.

Advocacy & Awareness

NYLA Advocacy Day is scheduled for Friday, February 26. This year Advocacy Day will be all virtual. Please participate in whatever way works for you, and encourage others from your community to do the same. Because of the deficit budget situation, this will be an unusually uncertain year. Please be vigilant in responding to all requests to send emails and letters to state officials. We are hopeful that the virtual model, while less effective in some ways, may allow for more participation.

Wade continues to work with The Community Library in Cobleskill on the community forum part of their planning process. The virtual gatherings have been surprisingly effective. Both Middleburgh and Fort Plain are interested in similar planning activities once things open up a bit.

We have received three Advocacy Grant applications in the current cycle. All involve libraries doing community engagement as a preface to important budget votes. Applications are as follows:
