Mohawk Valley Library System Director's Report November - December 2019

Administration & Governance

We finished 2019 with an \$81,000 surplus, due in large part to a reversal of the situation we had at the end of 2018. Since we had \$40,000 worth of JA related bills from 2018 that were paid in 2019, and libraries in general were reasonably current with bills paid in 2019; we took in nearly \$40,000 more in JA income in 2019 than we paid to JA. This puts us in good shape to begin 2020. We received all expected aid and other income in 2019, including a \$13,000 Assembly Bullet Aid award to Gloversville.

Christina Knee and Bonnie Kerr have suggested we hold the 2020 MVLS Annual Meeting at Justine's Restaurant in Cobleskill. Kathy is working on the details. It has been quite a few years since we have been to Schoharie County.

On the subject of meetings in more remote places, I suggest that we make a tradition of annually having 2 MVLS board meetings at member libraries. Can we plan on having the April meeting at a member library? There are 4 libraries that we have not visited in at least 10 years – Fonda, Fort Hunter, St. Johnsville and Sharon Springs. I suggest we choose one to visit in April.

We have received the annual audit review proposal from T.M. Byxbee. The 2020 cost will remain the same, at \$3,750 for MVLS and \$2,850 for JA. Since the audit firm works for the board, this requires action at the board meeting.

We had a couple of weather delays in November-December and were closed on December 2. If Schalmont schools are either delayed or closed, MVLS usually will open at 10:00. Occasionally, if the weather is truly dangerous, MVLS will close.

As we have discussed at previous meetings, the MVLS CSEA unit has voted to dissolve. Our previous union agreement ended on 12/31/2019. All former union employees have signed letters requesting that we no longer collect and pay union dues on their behalf. I have been in regular contact with our attorney, Kathryn McCary, as this has progressed.

Since we no longer have a current union agreement to guide the salaries and benefits for 2020, we will hold an executive session at the January meeting to discuss and act on those issues for 2020. Kathryn's recommendation is to keep things steady during the transition.

Over the next few months, we will be working to update the MVLS Personnel Manual to incorporate information that previously existed only in the union agreement. On health insurance, for example, the Personnel Manual simply states that we will provide benefits as stipulated in the union agreement. In this and many other instances, we need to incorporate that specific language into the Personnel Manual.

Automation and Resource Sharing

The JA Council will hold the first meeting of 2020 at SALS on January 8. That meeting typically includes action on the member fees for the following year, in this case for 2021. The JA Finance Committee held an open meeting on December 11 to get member input. The consensus at that meeting was to repeat the 3% increase that is in effect for 2020. This will increase projected fee income to \$747,837 in 2021. This will put the JA operation in excellent financial condition.

JA staff continues to work on full implementation of the hosted Polaris service. While there are a few ongoing issues, the migration has largely been positive. Staff also continues to improve the telecommunications network. Several sites have been upgraded. Over the next year, we will be developing a new rubric for how libraries are charged for telecommunications.

Arnoff Delivery service has been working out well. We continue to monitor performance on the new routes. Overall, items are reaching their destination within 3 days. Over 1 million items went through MVLS delivery in 2019. All three regional library systems – MVLS SALS and UHLS – are now using Arnoff for delivery service.

MVLS contracted with Empire Delivery through CDLC which interfaces with CDLC and UHLS libraries, as well as other academic libraries statewide. In November/December, 38 items were delivered to MVLS and 26 items left for returns or to fill requests outside of MVLS/SALS.

Publisher's free preview books continue to rotate among the member libraries, assisting libraries with selecting children's books. Once they complete the preview rotation, books are available for use in collections, giveaways, or added to library collections. 2040 books were received in 2019.

The Central Library Advisory Committee has met, and we now have an approved 2019 CLDA Final Report and an approved 2020 CBA plan. Both are posted on the MVLS website at: <u>http://www.mvls.info/insidemvls/mission-plan-of-service/plan-of-service/</u>. The proposed 2020 CLDA plan is also there. These two 2020 plans require approval by the MVLS board. They are little changed from 2019.

Outreach & Adult Services

Lois is retired! We held a staff gathering to honor her on December 17 and the Director's meeting of December 19 served a similar purpose. Lois did a good job of finishing projects and leaving us with the information that we will need for all ongoing initiatives.

We have rebranded the job as the Public Engagement and Education Consultant, and have developed a new job description, which will be posted with the meeting materials. Approval will be a January agenda item. We will then advertise the position, and look to have it filled before summer. It is exciting to be refocusing system services toward public engagement, removing barriers to access, and library customer service.

The NYSCA project is complete for the 2019 year, and the final report has been submitted. There were 37 program sessions and 274 total participants. Libraries are in the process of scheduling 2020 activities.

There was another session of the "Write for Your Life" program at the Hale Creek facility, reaching 73 inmates. This continues to be a very effective and well-received program. Purchasing for the county jails has been completed for the year.

Youth Services

The 2020 Summer Reading Planning Workshop will be be held Jan. 30 at SCPL. This year's CSLP artwork and manuals were pulled back and redone due to issues with artwork. Information was shared with members, and all up to date information is now only on the CSLP for the Imagine Your Story theme.

Our initial joint planning meeting with UHLS libraries for the 2020 Read It Forward Project is scheduled for January 8. Participating libraries selects one teen title, which is then purchased and "offered" to teens to read during the summer, and then give to another teen. RIF orientation will be offered to our new member library directors, with the hope of increased participation by MVLS libraries.

Early literacy support materials were received (\$250 for each library in attendance at the Baby Steps/Big Play workshop held in October) and sent to participating members. With increased reporting guidelines in place, the year one final budget report is being updated as expenditures are made.

MVLS received 964 paperback books from the First Book program offered through DLD grant of \$3000, 90% are appropriate for preschoolers. Member libraries have been in contact with their community laundromats and food pantries as locations to distribute to needy children. Wade Abbott is working with us on marketing and signage. Once all the books have been distributed, we will distribute our preview picture books. This little library effort will roll out in January/February 2020.
